S. R. O. No. 640/2013.—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Service Act, 1968 (19 of 1968) the Government of Kerala hereby make the following Rules further to amend the Kerala Jail Service Special Rules, 1958, issued under G. O. (Ms.) No. 1122/58/PD dated 16th September, 1958, namely:—

#### RULES

1. , Short title and commencement.—(1) These rules may be called "The Kerala Jail Service (Amendment) Special Rules, 2013".

- (2) They shall come into force at once.
- "2. Amendment of the rules.—In the Kerala Jail Service Special Rules, 1958, in the table under rule 3, in the entries against category "(9)" in column (1), after the entry "By transfer" in column (2), after the entry "(1) Degree of a recognized University" in column (3), the following "Note" shall be inserted, namely:—

"Note:—In case of persons who entered the Jail Service on or before the 17th February, 2010 a pass in the S. S. L. C. or its equivalent examination is sufficient"."

#### **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

Government have prescribed Degree from a recognized University as one of the qualifications for appointment by transfer to the post of Deputy Jailor/Superintendent, Borstal School/Jailor, Special Sub Jail/Lecturer in Law of State Institute of Correctional Administration. Most of the employees in service who are expecting promotion after a long period of service will be outside the purview of promotion as no time is left for them to acquire the required qualification. Government have hence decided to change the qualification prescribed for the above post in the case of employees who entered service on or before 17-2-2010 by transfer.

This notification is intended to achieve the above object.
