**ORDER**

As per rule 462 of the Kerala Prisons and Correctional Services(Management) Rules, 2014 the Jail Advisory Committee of Open Prison and Correctional Home, Cheemeni held on 15.02.2022, recommended the premature release of 51 prisoners.Accordingly, the Director General of Prisons and Correctional Services has furnished a detailed proposal in this regard vide letter read as 2nd paper above.
