ORDER

As per Rule 78, Part I, the Kerala Service Rules, earned leave is admissible for the period spent on duty. This position has been clarified in Circular No. 72/2005/Fin dt. 30.12.2005. Now several doubts have been raised as to whether the periods of Special Casual Leave as per Section II, Appendix VII, Part I, the Kerala Service Rules can be reckoned as duty for accrual of earned leave. As per the letter read above, clarification in this regard has been sought by the Accountant General as well.

Government have examined the matter in detail and are pleased to order that the periods of absence due to Special Casual Leave under Section II, Appendix VII, Part I, the Kerala Service Rules, will not be reckoned as duty for the purpose of accrual of earned leave. However, past cases settled otherwise if any, will not be reopened.


