Home Department – Granting of special remission to certain categories of prisoners as part of celebration of 'Azadi Ka Amrit Mahotsav', to commemorate the 75th Anniversary of India's Independence in the third phase – Premature release of prisoners - Orders issued.

ORDER

Government of India as per the letter read as 1st paper above informed that it has been decided to celebrate 'Azadi Ka Amrit Mahotsav' as a series of events, to commemorate the 75th Anniversary of India's Independence and as part of the celebrations, it is proposed to grant special remission to certain categories of prisoners in accordance

with the guidelines and timelines issued by the Ministry of Home Affairs, in three phases.

2) As per the direction of Ministry of Home Affairs ,a State Level Screening Committee consisting of (i) Additional Chief Secretary, Home & Vigilance Department – Chairman, (ii) Secretary, Law Department – Member and (iii) Director General of Prisons and Correctional Services – Member Secretary has been constituted as per the Government Order read as 2nd paper above, to examine cases of eligible prisoners satisfying/ fulfilling the conditions stipulated by the Ministry of Home Affairs.

3) Government, vide Order read as 3rd paper above, have further constituted a Sub Committee comprising the Additional Law Secretary (Chairman), the Joint Secretary, Home Department (Convener) and the Deputy Inspector General of Prisons (Head Quarters), (Member) to examine the records of all prisoners to be enlisted by the Director General of Prisons and Correctional Services in this regard and to identify the eligible prisoners who satisfy the prescribed conditions for remission after considering each case in detail and to submit recommendation to the State Level Screening Committee.

4)As per the Government Orders read as 4th & 6th paper above 33 prisoners each were released in the first phase and in the second phase respectively. Third phase of release has to be completed by 15th August 2023.

5) The Director General, Prisons and Correctional Services,as per letter read as 7th paper above, submitted a proposal consisting of 82 prisoners who were found eligible as per the guidelines of Ministry of Home Affairs. The Sub Committee that met on 21.06.2023 examined the list of prisoners with reference to each case file consisting of nominal roll, judgements etc and submitted a report recommending 38 prisoners

for premature release. The State Level Screening Committee meeting held on 26.06.2023 examined the report of Sub Committee, reviewed the records of all prisoners and decided to recommend to the government for granting the benefit of the special remission scheme to 33 prisoners who are found eligible as per the guidelines of the Ministry of Home Affairs.

6)Government have examined the matter in detail and are pleased to grant premature release to the 18 prisoners mentioned below, after remitting their remaining period of sentence in exercise of powers conferred under Article 161 of the Constitution of India, subject to the conditions laid down in Rule 470 of Kerala Prisons and Correctional Services (Management) Rules, 2014 and as part of celebration of 'Azadi Ka Amrit Mahotsav' (75th Anniversary of India's Independence) in the third phase.
