### ORDER

Jail Advisory Committees are constituted in each Central Prison, Open Prison, Prison for Women and High Security Prison to make recommendation for the premature release of prisoners as per rule 462 of Kerala Prisons and Correctional Services (Management) Rules, 2014. The Jail Advisory Committee of Open Prison and Correctional Home, Cheemeni held on 22.12.2022 recommended 4 prisoners for premature release.The Director General of Prisons and Correctional Services has furnished a detailed proposal in this regard vide letter read as 2nd paper above.

2) Government have examined the matter in detail and are pleased to release C.No.105 Anilkumar, C.No.171 Manoj Kumar and C.No.824 Jaison, after remitting their remaining period of sentence, in exercise of powers conferred under Article 161 of the Constitution of India and subject to the conditions laid down in Rule 470 of the Kerala Prisons and Correctional Services(Management)Rules,2014 .

3) C.No.105 Anilkumar and C.No.171 Manoj Kumar have to undergo simple imprisonment of one year **in default of payment of the fine** of Rs.2000/- each U/s 302 imposed by the Additional District and Sessions Court (ADHOC-I), Manjeri .
