8. The tender should be addressed to the above Tender Inviting Authority in a sealed

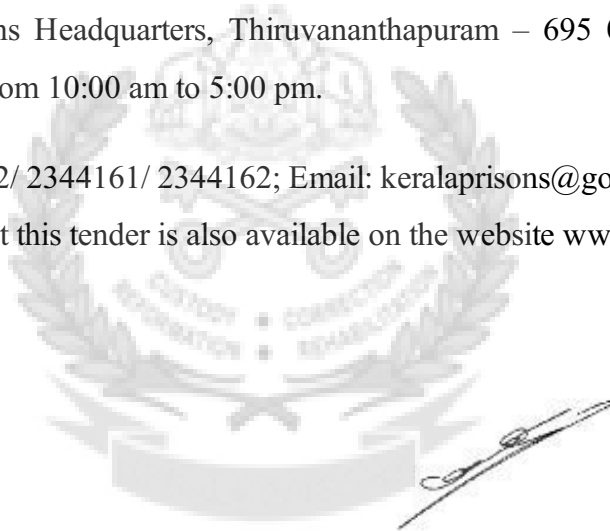


cover with the tender number and name duly superscripted on the cover.
