Abstract

Sainik Welfare Department- Scheme for providing Employment Assistance to the dependents of the Defence Personnel and General Reserve Engineer Force (GREF) / Border Security Force (BSF) Personnel and Central Armed Police Force Personnel (CAPF)- Submission of affidavit for the Protection of other eligible dependents is made mandatory for those who were already employed under the scheme -Orders issued.

ORDER

As per the Government Order read as 1st paper above, Government introduced a scheme for providing Employment Assistance to the dependents of the Defence Personnel and General Reserve Engineer Force (GREF) / Border Security Force (BSF) Personnel attached to military duty, killed/disabled/missing in action or died/disabled/missing due to reasons attributable to military service in peace time.

2. In the Government Order read as 3rd paper above it is made mandatory that the dependents of Defence Personnel and General Reserve Engineer Force (GREF) / Border Security Force (BSF) Personnel who apply for employment assistance shall submit an affidavit for protecting the deceased soldier's mother/father/widow/widower throughout their life and unmarried sister/ unmarried brother, till he/she attains the age of maturity. An

amount equal to 25% of the basic pay of the employed dependent will be recovered from the monthly salary of those, who violate the condition for the protection of other eligible dependents and this will be disbursed to the eligible dependents.

3. The Director, Sainik Welfare Department in his letter read as 4th paper above has requested that the conditions stipulated in the Government Order read as 3rd paper above shall be made applicable to those who were already employed under the employment assistance scheme for the dependents of Defence Personnel and General Reserve Engineer Force (GREF) / Border Security Force (BSF) Personnel

4. Government have examined the matter in detail and are pleased to order that the dependents of the Defence Personnel and General Reserve Engineer Force (GREF) / Border Security Force (BSF) Personnel who were employed in state service as per the employment assistance scheme shall submit an affidavit before their respective Office Head for protecting the deceased soldier's mother/father/widow/widower throughout their life and unmarried sister/ unmarried brother, till he/she attains the age of maturity. An amount equal to 25% of the basic pay of the employed dependent will be recovered from the monthly salary of those who violate the condition for the protection of other eligible dependents and this will be disbursed to the eligible dependents. The instructions in the Government Order read as third paper shall be followed for taking action against those employees who violate conditions in the affidavit.

5. As per the Government Order read as 2nd paper above, Government had extended the benefit of employment assistance scheme to the dependents of the Central Armed Police Force Personnel (CAPF). It is therefore necessary to make the Protection statement mandatory for the employment assistance scheme for the Central Armed Police Force Personnel (CAPF) also. Hence the dependents of Central Armed Police Force Personnel (CAPF) who apply for employment assistance under the scheme shall submit an affidavit for protecting the deceased Central Armed Police Force Personnel's mother/father/widow/widower throughout their life and

unmarried sister/ unmarried brother, till he/she attains the age of maturity. An amount equal to 25% of the basic pay of the employed dependent will be recovered from the monthly salary of those, who violate the conditions for the protection of other eligible dependents and this will be disbursed to the eligible dependents. The instructions in the Government Order read as third paper shall be followed for taking action against those employees who violate conditions in the affidavit.

6. The dependents of the Central Armed Police Force Personnel (CAPF) who were already employed in state service as per the employment assistance scheme shall submit an affidavit before their respective office head for protecting the deceased Central Armed Police Force Personnel's mother/father/widow/widower throughout their life and unmarried sister/ unmarried brother, till he/she attains the age of maturity. An amount equal to 25% of the basic pay of the employed dependent will be recovered from the monthly salary of those, who violate the condition for protection of other eligible dependents and this will be disbursed to the eligible dependents. The instructions in the Government Order read as third paper shall be followed for taking action against those employees who violate conditions in the affidavit.


