Order E1-22124/2022/PrHQ; Dated : 20-10-2022

Smt. Reesa, presently in the cadre of Senior Superintendent, had been sanctioned appointment on deputation basis to Norka Roots Satellite Office, Bangalore, with effect from 21.10.2017, vide G.O read as 1st paper above. Her appointment was subsequently extended up to 20.10.2022, vide government orders read as 2 to 5 papers above. The vacancy occurred in the category of Senior Superintendent, with effect from 04.06.2022, consequent on the deputation of Smt. Reesa had been filled up by the appointment of Smt. Manya M.C, vide this office order read as 6th above.

In the submission read as 7th cited, Smt. Reesa, Senior Superintendent has requested to permit her to rejoin duty in the Department w.e.f 21.10.2022, as the tenure of deputation expires on 20.10.2022. As there is no vacant post in the category of Senior Superintendent, is available for accommodating Smt. Reesa, one of the occupants in the category needs to be reverted. The process of demotion will affect the categories of Junior Superintendent (HG), Junior Superintendent, Head Clerk and Senior Clerk.

In the above circumstances, the following orders are issued to take with immediate effect from the FN of 21-10-2022.

1. Smt. Manya M. C, junior most in the category of Senior Superintendent, is reverted to the category of Junior Superintendent (HG), in the scale of pay of Rs.50200-105300/-.



2. Smt. Reesa, Senior Superintendent, on return from deputation, is permitted to join duty in this department, in the vacancy consequent to the demotion of Smt. Manya M.C with effect from 21-10-2022. She is posted as Senior Superintendent in Inspection Wing, vice, Smt.Suma.C, Senior Superintendent is transferred.

3.Smt.Suma.C, Senior Superintendent, Prisons Headquarters is transferred and posted in Central Prison & Correctional Home Thavanur.

4. Smt. Sheenamol S., junior most in the category of Junior Superintendent (HG) is reverted to the category of Junior Superintendent, in the scale of pay of Rs.43400-91200/-, with effect from 21-10-2022.

5. Smt. Manya M.C is posted in the vacancy of Junior Superintendent (HG), on 50200-105300/-, which will occur, consequent to the reversion of Smt. Sheenamol S. and posted as such at Prisons Headquarters in Inspection Wing.

6. Sri. Sreekumar S., junior most in the category of Junior Superintendent, is reverted to the category of Head Clerk on 39300-83000/- and posted in E6 seat at Prisons Headquarters

7. Smt. Sheenamol S., in the category of Junior Superintendent (HG) on reversion is appointed as Junior Superintendent at DIG office Kozhikode on 43400-91200/-, in the vacancy consequent to the reversion of Sri. Sreekumar S.

8. Smt. Divya T., junior most in the category of Head Clerk, is reverted to the category of Senior Clerk on 35600-75400/- and posted as such at Open Prison, Cheemeni.

9. Sri. Anilkumar R., junior most in the category of Senior Clerk, is reverted to the Category of Clerk on 26500-60700/- and posted as such at Prisons Headquarters, in the existing vacancy.
